**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE
BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT**

APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 5,848,490.27

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply, Delivery, and Installation of Air Conditioning Units (APP 2024), with an Approved Budget for the Contract (ABC) of ₱ 5,848,490.27 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on October 16, 2024;

WHEREAS, in response to the Invitation to Bid, four (4) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on October 30, 2024;

WHEREAS, in the public bidding held at the BAC Conference Room on November 13, 2024, at 3:00 P.M.:

- (a) Four bidders, namely, Metro Ilocos Appliance Inc., CGS Solid Aircon and Refrigeration Inc., Wintercool Ref and Aircon Services, and Sentine Development Corp., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the four bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Metro Ilocos Appliance Inc., CGS Solid Aircon and Refrigeration Inc., and Sentine Development Corp., to contain all the required documents and were rated "passed", while the first envelope of Wintercool Ref and Aircon Services was found to be ineligible due to an expired PhilGEPS Registration, which is not current and updated,
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the three bidders and found that the envelopes of the three bidders contained the prescribed documents and were rated "passed";
- (d) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the three bidders whose first and second envelopes were rated "passed",
- (e) the BAC resolved to declare Metro Ilocos Appliance Inc., as the bidder with the Lowest Calculated Bid (LCB) with a bid amount of ₱ 3,571,305.79,

- (f) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room and via zoom on December 18, 2024:

- (a) the TWG for the Legal and Financial Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the LCB was non-responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as non-responsive,

WHEREAS, The BAC through the Secretariat sent a Notice of Disqualification to Metro Ilocos Appliance Inc., on December 19, 2024.

WHEREAS, The BAC direct the TWGs to proceed with the Post-Qualification Evaluation of the 2nd LCB and report their findings to the BAC within the prescribed period.

WHEREAS, on December 20, 2024, Metro Ilocos Appliance Inc., sent its Motion for Reconsideration through email.

WHEREAS, on December 26, 2024, the BAC, through the Secretariat, sent a reply letter via email informing Metro Ilocos Appliance Inc. that its Motion for Reconsideration is denied.

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room and via zoom on January 22, 2025:

- (d) the TWG for the Legal and Financial Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (e) the TWG for Technical Aspect reported that the LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (f) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the 2nd LCB as responsive,

THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare CGS Solid Aircon and Refrigeration Inc., as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 4,013,121.00 and,
- (b) to recommend to the President the Award of Contract for the project Supply, Delivery, and Installation of Air Conditioning Units (APP 2024), to CGS Solid Aircon and Refrigeration Inc.
