WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Hardware Supplies and Materials (APP 2024-1st Qtr.), Rebid with an Approved Budget for the Contract (ABC) of ₱ 6,655,730.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on April 23, 2024;

WHEREAS, in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on May 2, 2024;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on May 14, 2024, at 3:00 P.M.:

- (a) Two bidders, namely, MZR Builders and Uptown Industrial Sales Inc. tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of MZR Builders and Uptown Industrial Sales Inc. to contain all the required documents and were rated "passed".
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the two bidders and found that the envelopes of the two bidders contained the prescribed documents and were rated "passed";
- (d) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the two bidders whose first and second envelopes were rated "passed",
- (e) the BAC resolved to declare Uptown Industrial Sales Inc., as the bidder with the Lowest Calculated Bid (LCB) for Lot No. 1 with a bid price of ₱ 335,296.50,
- (f) the BAC resolved to declare Uptown Industrial Sales Inc., as the bidder with the Single Calculated Bid (SCB) for Lot No. 3 with a bid price of ₱ 681,266.50,

- (g) the BAC resolved to declare MZR Builders, as the bidder with the Lowest Calculated Bid (LCB) for Lot No. 4 with a bid price of ₱ 1,398,920.00,
- (h) the BAC resolved to declare Uptown Industrial Sales Inc., as the bidder with the Single Calculated Bid (SCB) for Lot No. 5 with a bid price of ₱ 325,846.50,
- (i) the BAC resolved to declare Uptown Industrial Sales Inc., as the bidder with the Single Calculated Bid (SCB) for Lot No. 6 with a bid price of ₱ 754,967.00,
- (i) to declare a Failure of Bidding for Lot No. 2, no bid was received,

- (k) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB and SCB;
- (I) to recommend to the President the procurement of Lot No. 2 of the project Supply and Delivery of Hardware Supplies and Materials (APP 2024-1st Qtr.) using the appropriate alternative mode of procurement in accordance with the Implementing Rules and Regulations of R. A. 9184.

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) on June 27, 2024:

- (a) the TWG for the Legal and Financial Aspects reported that the LCB and SCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the LCB and SCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB and SCB as responsive;
